"Svane Wave mattress"

is a white colour mattress constructed of spring pockets (18 cm height springs) and a removable cover. Cover is composed of polypropylene backing (0.2 cm), FR-polyether filling (0.5 cm), polyester fiber filling (4 cm) and Kanecaron FR textile (0.2 cm).

Total mattress thickness: 180 ± 5 mm.
